SUBMISSION INSTRUCTIONS AND FORM



1. The name and qualifications of the nominee must be typed or legibly printed on the application form. The nomination must be approved and the form signed by the Pound Keeper, and Pound's Dog Robber, verifying that all information submitted is correct. If the Pound Keeper or Dog Robber is the nominee, then the Sr. Vice Pound Keeper shall sign the nomination form.
2. Only one (1) nomination, within the Florida Pack, from each Pound will be accepted and must first have been voted by Pound members at a regular Growl of the Pound and recorded in the scratching's as their Nominee for Pack Dog of the Year.
3. The nomination **form and any additional pages can be mailed or emailed** to the Chairman. If sent by mail, please print on the left bottom of the envelope, "PDOY Nomination." and mail to the Chairman of the D.O.Y. Committee. The name and address are located at the bottom of this letter.
4. The name of the Devil Dog of the Year will be announced at the Department Convention Banquet.
5. Eligibility: Any Pedigreed Devil Dog or Devil Dog, in good standing in any Pound within the Florida Pack, **and who meet the following qualifications for the Past Twelve Months** may be submitted:
 - a. Activities within the Florida Pack that demonstrate devotion to the Marine Corps League, Florida Pack, and Pound.
 - b. Achievements and activities in the Marine Corps League, Florida Pack, Pound, and other Veteran's groups.
 - c. Achievements and activities in the community, civic and social groups which enhance the posture of the Marine Corps League, the Florida Pack, and the Marine Corps.
 - d. Currently holds or has held any elected or appointed office in Pound, Pack or Kennel.

The Devil Dog of the Year Committee will consist of all past Pack recipients of the award, present at the convention.
